

**SUMMARY ANNUAL REPORT**  
**FOR DENTAL PLAN FOR BMI ACTIVE STAFF**

This is a summary of the annual report of the Dental Plan for BMI Active Staff, EIN 31-4379427, Plan No. 543, for the period January 1, 2003 through September 30, 2003. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Battelle Memorial Institute has committed itself to pay all claims incurred under the terms of the plan.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$522,215 as of September 30, 2003, compared to \$0 as of January 1, 2003. \$181,584 was transferred into the plan from the Battelle Memorial Institute Dental Assistance Plan on September 30, 2003. During the plan year the plan experienced an increase in its net assets of \$340,631. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$4,347,135 including employer contributions of \$3,947,907, employee contributions of \$382,693, and earnings from investments of \$16,535.

Plan expenses were \$4,006,504. These expenses included \$183,948 in administrative expenses and \$3,822,556 in benefits paid to participants and beneficiaries.

1. an accountant's report;
2. financial information and information on payments to service providers;
3. transactions in excess of 5% of the plan assets; and
4. information regarding any common or collective trusts, pooled separate accounts; master trusts or 103-12 investment entities in which the plan participates.
