

SUMMARY ANNUAL REPORT
FOR BATTELLE EMPLOYEES' SAVINGS PLAN

This is a summary of the annual report for the Battelle Employees' Savings Plan, EIN 31-4379427, Plan No. 003, for the period July 1, 2001 through June 30, 2002. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$25,060,000. These expenses included \$133,000 in administrative expenses and \$24,927,000 in benefits paid to participants and beneficiaries. A total of 8,014 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$664,372,000 as of June 30, 2002, compared to \$674,355,000 as of July 1, 2001. During the plan year the plan experienced a decrease in its net assets of \$9,983,000. This decrease includes unrealized appreciation and depreciation in the value of plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan experienced a net loss of \$11,773,000 and net transfers of \$1,790,000. This amount includes employer contributions of \$12,863,000, employee contributions of \$39,206,000, realized losses of \$1,717,000 from the sale of assets, and a loss from investments of \$37,065,000.

3. assets held for investment; and
4. transactions in excess of 5% of the plan assets.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Battelle Memorial Institute, 505 King Avenue, Columbus, OH 43201) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
